The Scholastic Review Committee meets on a regular schedule, every other week, during the academic year. The committee also holds meetings for review during summer term.

Student petitions are reviewed at each meeting. At the end of each term the committee meets for End of Term Review, (EOTR). At EOTR the records of students who were disqualified are reviewed. The committee may elect to

cancel a student's disqualification if they deem the reason for disqualification to be due to extenuating circumstances.
